I understand there are risks of serious injury ranging from panic, hyperventilation and sun stroke to more serious injuries such as heart attacks, drowning, permanent disability and death, as well as severe social and economic losses which might result not only from my own action, inaction, or negligence, but action, inaction or negligence of others, the rules of play, or the condition of the premises or of any of the equipment used. Further, I understand that there may be other risks not known or not reasonably foreseeable at this time.

3. Assume all of the foregoing risks and accept personal responsibility for the damages following any such injury, permanent disability or death.

Release, waive, discharge and covenant not to sue MAUI CANOE CLUB, its members, its directors, its agents, its steerers (captains) and other volunteers of the MAUI CANOE CLUB, other participants, owners and lessors of the premises, used to conduct the event or activity, all of which are hereinafter referred to as "releasees", from demands, losses or damages on account of injury, including death or damage to property, caused or alleged to be caused in whole or in part by negligence of the releasees or otherwise.
